**As of April 1, 2016 our student population is 1488; 424 at LES, 342 at JES, 317 at the middle school and 405 at the high school. I will be bringing forward to you at next board meeting dates that the elementary schools can work 1/2 days on curriculum before the end of the year in order to make reconfiguration successful. Pending no more snow days elementary school teachers will need to have, by the close of the custodian business day on the June 17th, all of their rooms packed. On Monday, June 20th the custodians will start moving classrooms. Ken Vining has brought over boxes to the schools, they are well on their way. I met with the district Librarian, Suzanne Cole today and she presented to me a plan on moving libraries around between June 20th and June 30th. Also, at our next meeting I will be bringing probationary teachers to you for your consideration. I will be on vacation May 11 through May 17, Kevin will be the Board Secretary on the 12th and he will have a report at that time. Denise Rodzen asked about books being moved from one library to another, wanted to make sure that at the primary school there would be books for more advanced students to read there. Mr. Healey responded that accommodations have been made for those students.**

The sophomores took the ASVAB test on Wednesday. This is an aptitude test, it is about trying to find out where the students interests lie. For the last 5 late arrival Wednesday's at the high school we were able to finish our school wide rubrics in order for our NEASC accreditation next year. Our staff were very excited that we got through that piece. That time that was allotted was very useful. There was a Performance Based meeting for 8th grade parents to inform them of the theory of where we are headed. Parents had great questions. There are going to be more and more of these meetings with the next one after vacation. Kim Bryant is creating an electronic timeline for where Spruce Mountain High School is right now. You will be hearing more as we get closer to the piece to where you need vote on graduation requirements.
