- 15.2 Consideration for approval of fuel storage agreement with the town of Jay.
Superintendent Healey reported that the ruptured fuel tank would cost approximately \$60,000 to replace. We have a less expensive alternative. We have talked to the officials in Jay and after going back and forth a few times the town of Jay came up with a proposed plan. That plan is to charge the district a surcharge of 7.5 cents per gallon and an annual maintenance fee of \$1,000. If the maintenance fee is not used each year the town keeps the fee. This works out to be \$2,550.00 for fuel and \$1,000 for maintenance for a total annual cost of \$3550.00 per year. My recommendation is that we make an agreement with the town of Jay for a 5 year period. The Town of Jay has the ability to withdraw from the agreement with a 12 month
