## **Professional Committee Stipends**

In accordance with Article 17 of the 2014-2017 Collective Bargaining Agreement Between the RSU 73 Board of Directors and the RSU Education Association (Professionals), the following Memorandum of Agreement is set forth regarding Professional Committee Stipends.

Teachers who accept a voluntary offer to participate and serve on a committee listed below shall receive the stipends indicated at the end of the school year, provided that a member attends two-thirds (2/3) or more of the scheduled committee meetings and is an active participant in the work of the committee.
